What is the overall <u>deductible</u> ?	\$400 individual/\$1,200 family <u>network</u> . \$800 individual/\$2,400 family out-of- <u>network</u> .	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this plan begins to pay. If you have other family members on the policy, the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay.
Are there services covered before you meet your <u>deductible</u> ?	Yes. Office visits, <u>preventive care services</u> , <u>emergency room care</u> , <u>emergency medical</u> <u>transportation</u> , <u>urgent care</u> , and <u>prescription</u> <u>drug</u> benefits are covered before you meet your <u>network deductible</u> . <u>Copayments</u> and <u>coinsurance</u> amounts don't count toward the network deductible.
